The Adviser has contractually agreed to waive its fees and/or absorb expenses of the Fund to ensure that net annual fund operating expenses (excluding acquired fund fees and expenses of 0.01%, interest, taxes and extraordinary expenses) do not exceed 1.15% of average daily net assets of the Investor Class and 0.75% of the average daily net assets of the Institutional Class. This contract's term is in effect through at least February 27, 2020, and may be terminated only by the Trust's Board of Trustees (the "Board"). The net expense ratio represents what investors have paid as of the prospectus dated 02/28/2019.

From time to time the Fund may invest in shares of companies through initial public offerings (IPOs). IPOs have the potential to produce substantial gains. There is no assurance that the Fund will have continued access to profitable IPOs and as the Fund's assets grow, the impact of an IPO investment may decline.
