The Adviser has contractually agreed to waive its fees and/or absorb expenses of the Fund to ensure that net annual fund operating expenses (excluding acquired fund fees and expenses, interest, taxes and extraordinary expenses) do not exceed 1.68% of average daily net assets of the Investor Class and 1.28% of the average daily net assets of the Institutional Class. This contract's term is in effect through at least February 28, 2025, and may be terminated only by the Trust's Board of Trustees (the "Board"). The factors are equally weighted when forming a composite signal where Growth is considered to be a negative indicator and thus flipped to be a negative. The Index is market-capitalization-weighted.
