This contract's term is in effect through at least February 28, 2026, and may be terminated only by the Trust's Board of Trustees (the "Board"). The factors are equally weighted when forming a composite signal where Growth is considered to be a negative indicator and thus flipped to be a negative. The Index is market-capitalization-weighted.
